- Ensure that products meet safety and quality standards by collaborating with engineering, quality assurance, and testing teams during product development and production processes.
- Verify that product labelling, packaging, and instructions comply with applicable laws, including warnings, usage instructions, and language requirements.
- Manage the process of obtaining and maintaining necessary certifications, approvals, and permits for products, such as CE marking, FCC approval, and other industryspecific certifications.
- Conduct risk assessments to identify potential product-related hazards and work with relevant teams to implement risk mitigation strategies.
- Maintain comprehensive records of compliance activities, test results, and certifications. Prepare reports on compliance status for management and regulatory agencies.
